I want to wish everyone a Happy New Year, and if you are new to the neighborhood, welcome to Forest Parks. I hope you enjoy this neighborhood as much as my wife and I enjoy it.

First of all, last year we began a new HOA and it was a pretty good year for the neighborhood. The HOA was able to add a little color to the front entrances by planting some flowers, and we also saved money by doing the work ourselves. We were able to pay the water and electric bill all year, and pay for a landscaper to manage our entrances.

Although we were able to maintain the entrances to a degree, there were other important items on our list that we were unable to achieve due to funding. Some of these items were: insurance on the entrances, replace the broken light fixtures at the entrance, finish buying the improved street signs, and finally one big item we would really like to do is reduce the natural areas by the back entrance and replace them with sod.

Last year we had only a third of the neighborhood supporting the HOA. I understand that times are hard, and paying the full one-hundred and fifty dollars might not be an option for all of the families living in our neighborhood. Your HOA is more than willing to work with you and break the amount down into two to three payments. The fact of the matter is that it is the neighborhood that keeps the HOA alive. This year I would like to meet all of our goals, but I can't do it without your support and help. I would love to see enough money come in, so not only can we meet our goals, but we can also have a neighborhood "block party." Neighborhoods are supposed to be a fun, safe place for families to live. With your support...we can keep our neighborhood one of those places.
